### Parent (s) or Guardian (s) Agrees To:

- Pay tuition or fees and expenses in advance each month the student is enrolled at Northwoods.
- Provide proof of medical and dental insurance coverage as of the date the student is enrolled at Northwoods.
- Pay for those expenses not covered by medical and dental insurance, including medications and test.
- Pay other expenses incurred by the above-named student as incurred and regularly billed by Northwoods.

### Services Provided by Northwoods:

- Provide an educational opportunity commensurate with the student's abilities and capacities.
- Furnish the student with adequate room and board.
- Schedule vacations, holiday's and visits.
- Comply with the provisions of Northwoods' Children's Residential Care Program license as administered by the Idaho Department of Health and Welfare.
- Northwoods is not responsible for students personal items

### Other Terms and Conditions:

1. **Payment Schedule:** Tuition is due and payable monthly, in advance, on the first calendar day of the month. Tuition and other fees are subject to late charges if not received according to this schedule. Thirty (30) days after payment is due, late charges will be incurred at the APR of 1.5% per month. The undersigned parent (s) or guardian (s) agree to pay reasonable attorneys fees and costs that may be incurred in the enforcement of this payment schedule.
2. **Fees Payable Upon Admission:** The following fees are payable upon the student's admission at Northwoods:
  - A)An admission fee of \$500.00.
  - B)A pro-rated daily rate of \$132.00 for the number of days left in the current calendar month.
  - C)One month's tuition \$3950.00 for the next calendar month following enrollment.
  - D)Last month's tuition of \$3950.00. Upon successful completion of the 12 month Northwoods program, the student's previously paid last month's tuition shall be applied toward the student's last month's enrollment. This last month's tuition is non-refundable if the minimum stay requirement has not been met.

3. **Early Termination by Northwoods:** The undersigned parent (s) or guardian (s) acknowledge and agree that because of the significant staffing and administrative costs not otherwise incurred by Northwoods in such an event, Northwoods shall not refund any portion of the student's current month's or last month's tuition in the event of the student's unscheduled termination from enrollment. An unscheduled termination is considered to be a student who runs away or a student whom Northwoods determines, in its sole discretion, to be inappropriate for continued enrollment at Northwoods. Upon successful completion of the Northwoods 12 month program, the student's previously paid last month's tuition shall be applied toward the student's last month's enrollment.
4. **Early Termination by Parent (s) or Guardian (s):** In the event the undersigned parent (s) or guardian (s) decide to terminate the student's enrollment prior to completion of the 12 month Northwoods program, the undersigned parent (s) or guardian (s) acknowledge and agree that because of the significant staffing and administrative costs not otherwise incurred by Northwoods in such an event, Northwoods shall not refund any portion of the student's current month's or last month's tuition.
5. **Misrepresentation or Omission:** The information submitted for enrollment, included but not limited to, application forms, medical history, and physical examination, are part of the Contract for Services, and, should there be any misrepresentation or omission made on said forms, Northwoods reserves the option, in its sole discretion, to dismiss the student. Furthermore, the undersigned parent (s) or guardian (s) agree to be responsible for and assume liability relating to any matters that occur as a result of any such misrepresentation or omission.
6. **No Warranties of Guarantees:** The undersigned parent (s) or guardian (s) agree and acknowledge that serious circumstances in the student's life have resulted in the student being enrolled at Northwoods. The undersigned parent (s) or guardian (s) further agree that because of said serious circumstances Northwoods makes no warranties or guarantees, express or implied, to the parent (s) or guardian (s) that the services provided by Northwoods will be successful to any degree for the student.
7. **Dismissal or Removal:** Northwoods reserves the right to dismiss the student from enrollment with the undersigned parent (s) or guardian (s) agreement if, after enrollment, it is the opinion of Northwoods that the student's behavior jeopardizes his physical or emotional health and/or safety, or that of other students and/or staff of Northwoods. The undersigned parent (s) or guardian (s) agree and acknowledge that parental or guardian failure to support the student's participation at Northwoods, either emotionally or financially, also can result in dismissal of the student. Any decision to dismiss a student under the above conditions will be made in the sole discretion of Northwoods. The undersigned parent (s) or guardian (s) shall have the right to terminate the student's enrollment and remove the student from Northwoods at any time.
8. **Governing Law:** This contract for services shall be deemed to have been entered into in the State of Idaho and all questions of the validity, interpretation, or performance of any of its terms or conditions, or any rights or obligations of the parties to this contract for services shall be construed according to the courts of the State of Idaho.
9. **Authorization:** The undersigned parent (s) or guardian (s) hereby specifically authorize Northwoods to provide residential care and services to their son during the period of time their son is enrolled at Northwoods.
10. **Financial Responsibility:** The undersigned parent (s) or guardians (s) acknowledge that they are responsible for all fees and expenses incurred on behalf of the student.
