Attorney: Further charges likely against Mobile judge accused of paddling prisoners

MOBILE, Ala. -- Herman Thomas' attorney, Bob Clark, said Thursday that he was "reasonably certain" that more indictments against the ex-judge soon would emerge from a special Mobile County grand jury.

The 48-year-old Thomas, who left the <u>Circuit Court</u> bench in October 2007 under pressure, <u>was indicted in March</u> on charges that included kidnapping, extortion and sodomy in connection with criminal court defendants.

He's accused of sexually assaulting inmates under his power and, in some cases, paddling them. The March indictment listed nine victims.

Clark said he believes that at least two more accusers -- and subsequent indictments -- might spring from a special grand jury session meeting this week at the courthouse at Mobile Government Plaza.

<u>District Attorney John Tyson Jr</u>. declined comment Thursday and would not say whether a special grand jury had gathered this week. Grand juries meet in private and generally hear only the prosecution's case and not from the defense.

Chief Assistant District Attorney Nicki Patterson, who will head the prosecution against Thomas, was unavailable for comment.

But Clark said Patterson recently hinted there could be more accusers coming down the line.

The attorney also suggested that if more indictments are issued, they would be "more of the same" -- accusations of paddling, sexual misconduct and Thomas' use of office for personal gain.

"We are all grown people," Clark said, and, if new indictments are indeed issued, "I would expect the professional courtesy of (prosecutors) asking me to 'Bring your client down to you-name-it, the courthouse or the docket room,' and we will be there."

Thomas' March arrest did not go as smoothly. Warned that it was pending, Clark and Thomas held a brief news conference in front of the Mobile County Metro Jail, with Clark using the occasion to describe his client's travails as persecution based on racism.

Investigators with the district attorney's office interrupted the gathering, nudged Thomas toward the jailhouse door, then booked him on 57 counts.

Clark said he expects that any new indictments against his client would be incorporated into the pending case. Thomas' trial is set for Oct. 5.

Thomas, a one-time prosecutor who later rose quickly from a district judgeship to a seat on Mobile's circuit bench, was known for his vigorous and ceaseless community activism.

Early signs of Thomas' future troubles began to surface in 2006, when he overrode a fellow judge's decision ordering former school board member David Thomas, his cousin, to serve a week's sentence in Metro Jail for leaving the scene of a 2005 Mardi Gras accident.

Judge Thomas, without his colleague's knowledge, instead arranged for David Thomas to serve the sentence in the less-crowded Prichard Jail.
