## COPE MINISTRIES AND HEAL MISSION CONVERSION PROGRAM ENROLLMENT AGREEMENT

Former clients/customers, victims, survivors, staff, and/or surviving loved ones of the deceased who meet the description of the aforementioned will forthwith be referred to as Sponsors. Sponsors, the enrolled, and everyone are welcome to donate to the church and mission, however donations will not effect placement or enrollment status. The criteria Sponsors must meet for enrollment are as follows unless otherwise stated (i.e. who can be a Sponsor):

- 1. You must be a direct victim or witness with firsthand knowledge that the party to be enrolled engages in 2 or more of the following practices:
  - Deceptive Advertising/Misleading Marketing/Fraud
  - Excessive and/or Abusive Use of Physical/Chemical Restraints/Interventions
  - Restricts/censors/monitors communications with outside world
  - Operating without a license, accreditation, or qualified staff
  - Accepts involuntary enrollments without a court order in violation of due process
  - Engages in Coercive Thought Reform (behavior modification: aversive model)
  - Human Trafficking for Sex and/or Labor
- 2. You must specify what of the above criteria and include all that apply from that list and more when contacting admissions@cope.church to enroll an offending entity. Citing sources will assist with expediting placement or enrollment.
- 3. It is your choice whether to be a faith-based Sponsor or evidence-based Sponsor of your offender's enrollment. If faith-based, as part of the requirements for enrollment you provide Guest Sermon posted will need to (to he https://www.cope.church/sermons.htm, https://www.heal-online.org, and any information page provided by HEAL Mission on that entity) detailing the allegations warranting placement of the offender, reveal your full first and last name (not contact info unless you choose to do so), and answer the following question in the Guest Sermon, which should be provided in the body of an e-mail to rev@cope.church: "Did you report it to the proper authorities? If not, why? If so, what happened with the reports?" By enrolling an offending entity you are helping with consumer advocacy to inform the public. The public's most prominent question for all victims/survivors remains the one asked though in two parts. If evidence-based, the requirement is to file a complaint/report with the proper authorities (HEAL Mission and Rev. Angela Smith can help with navigating that process) and provide a copy of that where that won't be made public until the case is closed by the officials though the offender will be enrolled in the COPE Conversion Program and placed on the HEAL Watch-List without publicizing your identity. (These requirements in #3 are intended to address the issue of accepting involuntary enrollments without a court order which is the only enrollment criteria HEAL Mission/COPE Conversion Program currently matches in terms of practices that may result in program placement on the HEAL Watch-List/in the COPE Conversion Program. So, it is intended to lead by example or ask the Sponsors to do that by getting the virtual equivalent of a court order by reporting it to the proper authorities or if faith-based by providing a guest

sermon and trusting in the church rather than the state to hold public offenders accountable.)

Upon receipt of request to enroll an offending entity that matches the above criteria for both sponsorship and placement, the offender will be placed in the virtual conversion program and on the watch-list. Sponsors sponsor the enrolled with their words, testimony, and corroborating evidence and nothing more. Sponsors may be contacted regarding progress and provided opportunities to participate in the process after placement. It is important to remember that most enrolled in the Conversion Program or on the watch-list fail to change and end up in the virtual cemetery provided by the church. So, if you don't want them buried in virtual hallowed ground, please pray they convert or vote for their release when given the opportunity if concerned being buried in a virtual church graveyard permits them entry into heaven where you may still oppose that for good reason.

Once enrolled observation and risk assessment along with opportunities for advancement will be provided per existing and developing protocols.

There are only three ways off the list or out of the Conversion Program once enrolled. The enrolled can meet the Honesty In Marketing Standards explained at https://www.cope.church/standards.htm and graduate with placement on that page to show they met the minimum standard as described and will continue to do so. Should they graduate and backslide, notification of such will result in their being re-enrolled or again placed in the Conversion Program. The enrolled can be shown mercy and the Sponsor can request release prior to graduation and if the majority of Sponsors agree, mercy shall be granted. Said agreement can be implied through lack of interest, lack of support, or lack of participation with the church and mission. Or, the enrolled may find themselves buried in the virtual graveyard upon closure.

Please at least show any you wish to Sponsor at least the same consideration they've shown you to avoid hypocrisy. Open perpetual enrollment is presently available. Whether Conversion Programs are a necessary evil or not, is up to you.
