No, my legal name now is Janice Cole. I am okay with my email being posted, if nothing else, for others from the home who stumble on it and see they weren't forgotten or alone in what happened to them. I would like to add though, that one of the main things when a girl would arrive, is that the only 1 person in the whole program they were allowed to talk to for their first month was their room captain. Usually there were 5 beds to a room, but only 1 room captain. I figured it out pretty quick, they said they didn't want the new girls to be talking about anything 'worldly' and be a bad influence on the others until they got a grip of the rules and had the month for adjustment. In reality, they didn't want the other girls to tell the new girl what kind of stuff went on by the staff because the new girls were more willing to risk telling their parents on that once a week phone call, where a staff member was standing right there ready to hang up and take that phone call privilege away if they said anything they shouldn't. They girls who had been there a while weren't willing to risk that, cuz it was the only communication they had with their families and by the time a month rolled around, they had it beat in their heads they were stuck there no matter what they told their parents....

If your legal name is still Janice Mather and you'd like your e-mail posted as feedback as stated in the last reply, let me know. If your legal name is not Janice Mather, I need you to provide your current legal name if you wish for your message to be posted as a guest sermon. Attached is the progress report that will be posted at 8pm Pacific tonight on Happiness Hills in the event no one provides a recognized guest sermon before that time. As stated Happiness Hills AKA Still Waters AKA Solid Rock will be eligible for merciful release and removal from the active watch-list in 2025 if there are no new complaints provided and/or no one provides a guest sermon or evidence they reported it to the proper authorities under penalty of perjury by 2025.

There is still time for you to report the abuse to law enforcement as child abuse, child trafficking, rape, kidnapping, and murder have no statutes of limitation in Mississippi. I encourage you to report it.

If you would like your message to be considered a guest sermon, I'll need your legal first and last name as the author/guest sermonizer for the by-line on the sermon. However, you did not appear to include information on whether

or not you reported any abuse to law enforcement and what happened with any reports if you did report it. So, it is unclear whether or not you wish for that to be considered a guest sermon. I don't recognize it as such without your legal first and last name. And, if you were to provide that info without changing the body, I would include commentary that you answered the second question, but not the first.

I'm attaching the progress report I've prepared to upload tomorrow in the event there are no guest sermons provided by you or other survivors of Happiness Hills. Your previous reports to HEAL Mission were reviewed and part of the basis of the report.

I know there are horror stories and I witnessed many, although I was there willingly and didn't get mistreated myself except by Miss Becky and Miss Paula who had favorites, but Mr and Mrs Palmer's nephew is how I got in so I was a favorite of the founders which kept most of my torture to a minimum and I got a lot more privileges than the girls who were court ordered or family forced. That being said, the employee list needs updated a bit. MR Burke and Mrs Burke and their 3 kids worked there. Mr Burk worked in the school and other random stuff around the home. Mrs Burke was a cook and helped with non-dorm-mother stuff. Their 3 kids Renée, Revea, and Randy were there with us all the time but nobody was allowed to talk to Randy except his sisters. Before the Burkes, was a cook staff named Mrs Karen Dooley, who's oldest daughter was leaving the home at the same time she was hired on and they lived in a trailer on the property with Karen's other 2 daughters, who were very much a part of everything since they were girls. The Burkes and Dooleys were some of my favorite staff. Miss Paula, Miss Debbie and Miss Becky were sadistic cunts who liked to keep letters from a girl's family and not give them if they didn't have that girl as a favorite. One girl was made to eat past when she was full (eat every bite was the rule), and she threw up, and they made her eat her puke. Miss Paula was the worst with 'swats' she would spank anyone over the smaller stuff and she would come in swinging the paddle like she was chopping down a tree. If she hit bone, oh well, and if you moved, you got extra.

Still Waters Christian Boarding School AKA Solid Rock Boys Home FKA Happiness Hills (Still Waters) is on the HEAL Mission watch-list (of fraudulent and abusive programs) and enrolled in the COPE Conversion Program based on your reports to the HEAL Mission alleging fraud, abuse, and/or other violations. You can learn more or refresh your memory at https://www.heal-online.org/thelist.htm and/or https://www.heal-online.org/happiness.htm.

The HEAL Mission and COPE Conversion Program (for Conversion Programs) has updated our protocols to provide entities populating the watch-list and/or enrolled in the COPE Conversion Program three ways off the watch-list or out of the program. Death and/or closure remains one way after which they will be buried at http://www.beyondbusiness.net/youarenext.htm with the others who didn't make it off the list or reform in time. Programs enrolled in the COPE Conversion Program/placed on the watch-list are also eligible for graduation if they meet the minimum Honesty In Marketing Standards described and/or provided via hypertext link at https://www.cope.church/standards.htm. The third option is merciful release. Merciful releases are determined by date of last directly reported to the HEAL Mission complaint (date of incident(s) of abuse), whether those incidents occurred prior to when by custom or law the requirement to retain such records has expired, and whether Sponsors

(you) are actively participating or maintaining interest in holding your program accountable.

The most recent complaint the mission has received occurred in 2015 (if you were abused later than that then you did not include the dates of your enrollment when you contacted the HEAL Mission) on Still Waters/Happiness Hills. The custom is to retain such records for 10 years in Mississippi. So, the requirements for merciful release have not been met. This is an invitation for you to provide a guest sermon no later than Wednesday, June 9th, 2021 at 8pm Pacific if you wish to provide one rather than have a progress report posted at that time. For sermons (including guest sermons), see https://www.cope.church/sermons.htm and for progress reports see https://www.heal-online.org. Here's how to participate:

1. In the body of an e-mail message write out your complete sermon and include answers to the following questions:

Did you report fraud or other unlawful actions to the proper authorities? If not, why? If so, what happened with the reports? (So, 2 part question)

Why do you believe Still Waters/Happiness Hills/Solid Rock should remain enrolled in the COPE Conversion Program?

2. Send that guest sermon to me at rev@cope.church with your first and last name (full) and notify me if you wish for your contact information to be included or for all feedback to be handled by the mission and/or church. Your full first and last name will be shared along with your sermon as written and provided by you. It will be posted as a Guest Sermon at https://www.heal-online.org, https://www.heal-online.org/happiness.htm, and https://www.cope.church/sermons.htm.

If no one provides a guest sermon and there are no new complaints received by the HEAL Mission by December 31st, 2025, Still Waters/Happiness Hills/Solid Rock will receive a merciful release.
